The submitted information will be stored in VNLU registration database and may be used and updated to register for the next events organised by VNLU. If you have previously registered on the web resource, please log into your personal account, complete the **conference registration form** and submit your presentation materials.

The deadline for manuscript submission to scientific secretaries, roundtables, seminars for inclusion in the conference proceedings is August 4, 2025. Deadline for registering participants on VNLU webportal without a publication in the conference proceedings is September 20, 2025.

Working languages of the conference: Ukrainian, English, Polish, and German.

Only those materials that meet the established requirements and have not been previously published will be considered.

Requirements for scientific reports

- length up to 5 pages;
- abstract (up to 500 characters including spaces);
- keywords and main text (3-8 pages);
- reference list is not included

Materials that do not meet the requirements will not be considered. Only those materials that fully comply with the conference topics and are of scientific and applied significance will be accepted. The Organizing Committee reserves the right to make the final selection of reports for the conference based on the announced topics and qualitative criteria in the event when the reports do not align with the conference topics and of the reassignment thereof to another section, roundtable, seminar, while materials submitted after the specified deadline will not be reviewed.. In the event of rejection, the author will be notified by the section's scientific secretary via email within 10 business days from the date of registration.

The Organizing Committee of the conference ensures the compliance with the academic integrity principles and may, upon reviewing the manuscript, reject the author's submission where a plagiarism is detected. StrikePlagiarism.com is used to check for plagiarism.

Authors are responsible for the content of their abstracts, including the accuracy of the data, facts, other information, citations, translation accuracy, English texts of the report. Materials are not reviwed and are not returned, and are not subject to additional revision, so they must be carefully prepared.

Submission of a report to the Organizing Committee of the conference constitutes the author's consent to the publication of the report's text and metadata of the report (including first name, last name, patronymic, academic title, ORCID, and email address for communication). The electronic version of the abstract (or related correspondence) will be included in the electronic conference proceedings, which-according to Decree No. 352 of the National Academy of Sciences of Ukraine dated June 13, 2024—must comply with the open access policy in accordance with the Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 International License. This license permits free reading, copying, downloading, and distribution of materials with appropriate attribution, for educational and scientific non-commercial purposes, and without the right to create derivative works.

Abstract Formatting Requirements

- **1.** Length of abstract *up to 5 pages of A4* (297x210 mm); orientation – portrait; file format – Microsoft Word, version no older than 6.0; margins – 20 mm; font – Times New Roman; font size - 14 pt; line spacing - 1.5; text alignment - Justified (Normal); pages must be without numbering; do not use forced line breaks or extra spaces.
- 2. Structure of the abstract and formatting parameters consist of the following main components

alignment – left, no paragraph indentation:

main body of the scientific report:font - Normal; first line indentation – 1.25 cm; the text should include: statement of the problem, description of the main research materials, conclusions; without the list of references.

next line

alignment – left, no paragraph indentation:

The English section must contain the following items in order:

First and last names of the author (co-author) (transliterated), font - bold

academic degree, academic title, position.

alignment – *centered*, *no paragraph indentation:*

Title of the scientific report – sentence case, font style - bold.
